In accordance with article 228 of the Consolidated Text of the Securities Market Law, approved by Royal Legislative Decree 4/2015, of October 23, Naturhouse Health, S.A. ("**Naturhouse**" or the "**Company**") makes the following communication.

MATERIAL FACT

NATURHOUSE HEALTH, S.A. informs that on January 23, 2019, signed a liquidity contract (the "Liquidity Contract") with Renta 4 Banco, S.A. (the "Financial Intermediary"), with the sole purpose of promoting liquidity and regularity in Company share price, within the limits established by the General Shareholders' Meeting of the Company and by the current regulations in force, in particular, of Circular 1/2017, of April 26, of the National Securities Market Commission, on liquidity contracts.

The Financial Intermediary will perform the transactions subject to the Liquidity Contract in the Spanish regulated markets, through the market of orders, according to the contracting rules, within the usual hours of negotiation of these and as established in Rule number 3 of the previous named Circular of the CNMV.

For this purpose, following the previous acquisition period, the Company has deposited in the securities account associated with the Liquidity Contract fifty thousand five hundred twenty (50.520) shares of the Company. The balance of the cash account is one hundred and eighteen thousand two hundred and sixteen euros and eighty cents (118.216,80).

The period of validity of the Liquidity Contract is 12 months from the date of its execution.
